## **NEW IN 2025: COMPETITOR'S ENQUIRY FORM TO IMPROVE THE STEWARDSHIP PROCEDURES**

### **SUBMISSION REQUIREMENTS:**

- » The Enquiry Form must be completed by the affected competitor.
- » The form must contain specific details of the incident, including the time or lap, corner/zone of the circuit, drivers involved, and a description of the incident, with reference to the livestream time if applicable.

### **ELIGIBILITY CRITERIA:**

- » The incident must directly involve the competitor's driver, specifically where the driver is directly affected by another driver's action.
- » Incidents between two drivers witnessed by a third party are not eligible.

### **SUBMISSION DEADLINE:**

- » The Enquiry Form must be submitted within 30 minutes of the session's chequered flag.
- » Submissions must be made directly to the Race Director for analysis.

### **SUBMISSION LIMITS:**

- » Each competitor is allowed to submit the Enquiry Form a maximum of two (2) times per car during the Winter Series season.
- » Each submission counts to this limit. Once the limit is reached, no further requests can be submitted.

### **STEWARDS' DISCRETION:**

- » The Stewards of the Meeting may decide to return the Enquiry Form to the competitor if a favorable decision is made, allowing its use in future incidents.
- » There is no right to review, complaint, or appeal against the Stewards' decision regarding the analysis of the incident.

### **FORM COMPLETION:**

- » Incorrectly completed Enquiry Forms will be dismissed without analysis.

### **SCOPE OF ENQUIRY:**

- » Incidents previously reported and analysed by the Race Director/Stewards of the Meeting that resulted in a "No Further Action" decision are not eligible for the Enquiry Form and will be dismissed without the possibility of resubmission.

**RULES REGARDING THE SUBMISSION OF AN ENQUIRY FORM:**

- » The form must be correctly and accurately written, containing all details relevant for the investigation and delivered to the Race Director;
- » Submitted up to 30 minutes after the checkered flag is presented;
- » Must involve directly the car that is submitting the Enquiry Form;
- » Only 2 enquiries are allowed per car/season;
- » All enquiries not properly filled or about incidents with other cars or under investigation are not accepted and, therefore, dismissed;
- » Decision of dismissal or "**No Further Investigation needed**" is not subject to protest, right of review or appeal;
- » All decisions regarding penalties applied will be subject to Art. 14 and 15 of the ISC and other applicable prescriptions and regulations.
