## 2026 MEDIA GUIDELINES BY GEDLICH RACING

### INTRODUCTION

This document sets out and describes all the rules governing the activity of accredited media persons at Winter Series by GEDLICH Racing events during the 2026 Winter Series season. Before applying for accreditation, the applicant must read this regulation and accept its contents. GEDLICH Racing reserves the right to modify this document at any time, without notice and with immediate application.

### MEDIA ACCREDITATION REQUEST

For each round of the Winter Series, **any** person wishing to obtain media accreditation at the season or for the upcoming event must fill out the media accreditation application form and sign the liability waiver at the bottom of this document. This form can be found on [winter-series.com/media/media-accreditation/](http://winter-series.com/media/media-accreditation/). To be taken into account, the application for a media accreditation must imperatively reach to the Winter Series and therefore GEDLICH Racing marketing department no later than 7 days before the first day of the event (taking place on the Thursday before the racing weekend).

**Once the deadline has passed, applications will not be considered anymore.** Those who have made a request and have been accepted will receive a confirmation email with all the media information approximately 7 days before the event. Please consider the following:

- » There is no certainty that your application will be approved. GEDLICH Racing remains the right to accept or decline media accreditations at any time and without explanation.
- » A media accreditation (full season or single event) may be suspended at any time for noncompliance with the rules in this document and/or the rules of the circuits.
- » Obtaining one or more accreditations during past events does not guarantee the issuance of another media accreditation.
- » The media pass is nominative and cannot be transferred to a third party or person. In case of absence or unforeseen events, the media person undertakes to communicate as soon as possible. In case there is a replacing person, this information should be communicated to GEDLICH Racing immediately, providing the all documents like proof of insurance and contact details.

### MEDIA PASS, MEDIA JACKET & COMPULSORY LIABILITY INSURANCE

At the circuit you'll be handed a lanyard with media pass. This media pass gives media personnel access to the paddock, pitlane, service roads\* and grand stands of the circuit during the duration of the event.

A media pass for media personnel is subject to the existence of a **professional or civil liability insurance** with the function covered, and the mention "on track" valid, on behalf of the applicant (or his/her company), covering the risks incurred or caused by the events concerned with a minimum of € 3.000.000,00 (3 million euros). This insurance certificate must be attached to your application.

GEDLICH Racing cannot be held responsible for any damage caused to equipment of an accredited person or the person itself.

### MINIMUM AGE

In order to obtain a media pass for any GEDLICH Racing event, the person applying for accreditation must be at least **18 years old** on the first day of the event for which they have applied. Also, access to service roads is restricted to persons aged 18 and over.

## SAFETY EQUIPMENT

All accredited media persons must wear the following gear at all times:

- » A high visibility Winter Series media vest, loaned in exchange for a deposit of € 50,00 (cash) at the circuit in question, for the duration of the meeting, at all times at the circuit.
- » A mandatory helmet (for instance a bicycle helmet) when moving or driving on an (e-)scooter on **service roads** and in the **paddock** of the circuit. (no helmets/scooters lent by organisation or the circuit).
- » Closed shoes

Depending on the circuit/event venue, lockers will be available in the media center of the circuit.

## AUTHORIZED AREAS

This media accreditation combined with the media pass are only and strictly intended for media personal and cannot be transferred to a third party or person. Only this accreditation combined with the media jacket and media pass give access to the service roads.

Red zones, defined by the circuits are to be respected. Any media person that does not respect these zones or does not comply with the rules of the media accreditation and the rules of the circuit or organizing staff will have its media accreditation withdrawn. GEDLICH Racing has the right to exclude any person from the circuit and ban any person from events organized by GEDLICH Racing.

During each event, you will be given a map of the circuit, indicating the red zones. It is forbidden to stop and capture images in these areas. You are however allowed to cross these areas, with the utmost attention.

## SERVICE ROADS

In general, cars are not authorized to go on the service roads except for the cars that have the allowance from the organiser and have a car pass. Rules for the security roads can differ from circuit to circuit. Always read the information you've been sent 7 days before the event in order to be up-to-date with the rules of the particular circuit.

- » The service roads might have a one-way system (Motorland Aragón). If stated by the circuit, media personnel must drive in the same direction as the cars racing on track (unless stated otherwise).
- » The maximum speed on service roads at all times is 50 km/h.
- » Media accredited persons that move in the service roads must always stand at least 1m from the guard rails or safety walls. They will ensure that traffic in the service road is not obstructed at any time. Always make sure to park your vehicle in a spot where no other party is obstructed.
- » Wearing headphones or any device masking the surrounding noise is strictly prohibited, except for ear plugs that protect ones hearing.

## RACETRACK CROSSING

It is at all times forbidden to cross the racetrack. Even if there are no vehicles on track, it is strictly forbidden to move inside the barriers of the racetrack. In case of violation of this rule, the media accreditation will be withdrawn and any request for accreditation for future events will be declined.

## PIT LANE

For accredited media personnel, standing on the fast lane in the pitlane is strictly prohibited.

- » Do not interfere with the staff of the teams or the circuit.
- » You must at all times look in the direction of the entrance of the pit lane in order to ensure your safety environment.
- » Entering the pitlane is at all times at your own risk.
- » Standing at the pit wall is allowed from the 2nd lap onwards. Always make sure to look in the direction of the pit entrance when crossing the fast lane.

## STAFF AND MARSHALS

Whatever the guidelines set out by the circuit or in this document, the instructions of race stewards and members of the organisation, either from the circuit or from GEDLICH Racing are imperative and must be respected at all times. The event organisation and the circuit's personnel have, in the interests of security and safety, the right to modify or even cancel any decisions taken and communicated to the media during the various communications.

## OWN DECISION-MAKING & COMMON SENSE

The inherent dangerousness of motorsport requires the utmost vigilance from all persons on the circuit and its surroundings. Beyond the application of the rules, all accredited media personnel must show common sense, not to make decisions without permanently having the concern for their own safety and that of other people in and around the particular area. The work on and around the circuit requires constant attention and respect for simple precautions such as never turning your back to a moving vehicle like a race car or even a team truck.

## DRONES

The use of drones of any kind and in any case is **strictly forbidden**. Special requests for flying drones at the Winter Series events must be forwarded to the GEDLICH Racing marketing department at all times.

## IMAGE TRANSMISSION

Accredited photographers accept to provide GEDLICH Racing at least **15 photos** (paddock, pitlane, races, podiums, staff, etc.) per meeting, free of rights and logos and in JPG Format.

Photos must be send to [media@gedlich-racing.com](mailto:media@gedlich-racing.com) within 2 days after the racing weekend via WeTransfer or any other file transfer. The transmission of a larger amount of photos is allowed. The photo- and copyright rights belong entirely to their authors. However, accredited media grant GEDLICH Racing the right to use and modify their photos for its own communication via all media, material or immaterial, existing or future. GEDLICH Racing will make sure to give credit to the respective photographer by stating the name or social media account when publishing.

## PROPERTY

The media pass is only awarded if the safety standards are respected. Any breach of these media regulations will result in the withdrawal of accreditation by the race management or members of the organisation. Media jackets are property of GEDLICH Racing GmbH and shall in all cases be handed back to the organisation. In case of loss or damage, the deposit of € 50,00 will be kept by the racing organisation as a reimbursement for the media jacket.

## **WAIVER OF LIABILITY FOR MEDIA REPRESENTATIVES DURING EVENTS OF THE 2026 WINTER SERIES BY GEDLICH RACING**

**§1** I'm aware of the inherent risks and dangers associated with motor-racing events and undertake to abide by the instructions enacted by the organisers, race control, the marshals as well as the police and their representative (in written, verbal or visual form) promptly and - in particular - to not enter restricted areas or safety zones.

**§2** I accept that I'm acting at my own risk when leaving the area generally accessible for spectators and the areas explicitly designated by the race control - even if staying there is tolerated by the organiser

Explicitly designated by the race control are:

- All the areas designated as spectator areas,
- The entire paddock and service area including all the connecting roads and ways.

In have been made aware that staying in front of track boundaries, such as crash barriers or concrete elements, in restricted areas or safety zones and obvious danger zones is strictly prohibited.

**§3** I renounce for me and all the persons I am liable to provide maintenance to:

- GEDLICH Racing, the members organisations of the racing federation, its president, organisational bodies, Managing Directors, Secretaries General, board members, advisory-board members, members, full-time and honorary staff members,
- GEDLICH Racing GmbH, their full-time and honorary staff members,
- The organisers, their representatives, marshals and helpers,
- The circuit owners and their representatives,
- The drivers, passengers, vehicle keepers, vehicle owners, competitors and their helpers as far as it is about a race, a session aimed to achieve top speeds or shortest lap times or a timed or untimed practice session,
- Public authorities, racing services and other persons or institutions or institutions connected with the event's organisation, making claims on physical injuries, damage to property or financial losses - as long as the aforementioned injuries, damages and losses damages aren't the result of an injury of the life), the body and a damage of the health that were caused by an intentional or negligent breach of duty - even by a legal representative or assistant of the group of people discharged from liability - or other damages that were caused by an intentional or negligent breach of duty - even by a legal representative or assistant of the group of people discharged from liability.

The waiver of liability applies to claims based on any legal ground, particularly to claims for damages from contractual and non-contractual liability as well as to claims caused by prohibited activities. Implied disclaimers will remain unaffected by the preceding waiver of liability.

**§4** The areas explicitly designated by the race control for the media coverage are marked on the track map. I will take a close look at this map on every day of the event and will respect it and its prohibited zones (red zones).

**§5** I have been made aware that a breach of the aforementioned paragraphs can result in the revocation of my media accreditation and can result in legal consequences.
